# Selected Award-Winning Urdu Seerah Books Of Pakistani Females: Characteristics, Tendencies And Trends

**Abstract:** One of the features of Urdu Seerah is that competitions for the promotion and understanding of Seerah Tayyaba at the official level have been held in Pakistan since 2000. Competitions were held for Seerah books, Naat books, and essays.

The book "Rasool Akram" by Umm-e-Farooq received the first award to a female biographer in this category in 2000. As previously stated, the author illuminates the characteristics, aspects, and teachings of the Holy Prophet's individual and collective life (<sup>26</sup>) and describes the steps taken to educate women during the Prophet's lifetime. It is written from the perspective of "Khatoon-e-Khanakyzavianigah," a study of the Prophet's biography.

Some women's biographies have been nominated for the Seerah Award since its inception in 2010. Twenty-two people make up the group. As a result of government-level encouragement, both men and women began to contribute to the field of biography and began to contribute equally. Consequently, this article examines the characteristics, methods, and trends of the selected books by women biographers deemed worthy of the Seerah Award by the Pakistani government.

#### Introduction:

People of all ages can find inspiration and guidance from the Holy Prophet (PBUH). We can always find the best way to live in the Sira of the Prophet (peace and blessings of Allah be upon him), regardless of a person's place in life. Muslims have always known how important the Seera of the Prophet (peace and blessings of Allah be upon him) is. This scholarly tradition dates back to the

time of the Prophet and his Companions. However, biography writing was primarily limited to oral traditions at that time. In the later era of the Companions, biography gradually evolved and became a precise science; without exaggeration, tens of millions of books have been written on this subject over more than fourteen centuries, and the trend continues.

Looking back through history, it is clear that not only men but also women have fully participated in the biography field. However, the number of female biographers has been limited to less than that of men due to natural issues. Muslim women have contributed significantly to the biography field despite the social constraints that have prevented any prominent female names from appearing in this art. Consequently, it is essential to be aware of women biographers' significant and priceless contributions to the propagation of Islam and the sacred field of Sirae-Taiba. Furthermore, it is necessary to note that many female scholars have not only written on the subject but have also added fresh perspectives and modern biography trends, earning them the Sira Award from the Pakistani government. Because of this, it is essential to look at these books' features, methods, and trends.

#### The literary and terminological meanings of Seerah:

The word "Sirah" is the Arabic noun Masdar, which comes from the word ". "Al-Sirah" السيرة is the singular form, and "Al-Sir السيرة " is the plural. According to Ibn Manzoor, an Arabic lexicographer, "Sirah" means "walking," "manner and behaviour," "character and habit and trait.<sup>1</sup>"According to Ibn Manzoor, a character refers to one's Health and situation state. He says:

## السيرة: الهيئة. وفي التنزيل العزيز: سنعيدها سيرتها الأولى2

Character is referred to in biographies. It is written in Tanzil al-Aziz [the Holy Qur'an] that We will return it to its original state shortly.

Seerah is another name for this ailment concerning a particular individual. Therefore, Imam Ali bin Al-Jarjani states: "Literally, Sirat refers to the absolute way or character, whether that character or way is good or bad."<sup>3</sup>

The meaning of "Sirah" in Urdu is nearly the same as the term's purpose. In other words, a habit, a technique, a trait, a set of circumstances and occurrences, a way of life and biography, etc. The term "Sirah" relates to the life and circumstances of the Prophet of Allah; may God protect him and give him peace. The following are some that are mentioned within the "Urdu's Daira Maarif Islamiya":

#### " السيرة" هي الترجمة المأثورة لحياة النبي محمد عليه الصلاة والسلام-"<sup>4</sup>

The term "Sirah" refers to a collection of literature relating to the life of Hazrat Muhammad <sup>28</sup>.

A similar statement is made by the author of Urdu's Daira Maarif Islamiya:

"The first meaning of biography is the biography and biography of the Holy Prophet (PBUH)." $^{5}$ 

According to Muta'akhirin, the biography of the Holy Prophet (peace and blessings of Allah be upon him) is intended to illustrate the circumstances of a happy life. The word Sirah is derived from the word "Sir سير" and "Maghazi مغازى" were nearly interchangeable terms during the Companions and the Tabi'een period, and they both referred to the Prophet's recounting of his victories and battles.<sup>6</sup> Al-Seer السير and Al-Maghazi المغازى were the names given

to books that were written for campaigns and competitions, such as Ibn Shihab Zahri's, Muhammad Ibn Ishaq's, and Mu'ammar Bin Rashid al-Azdi's "Al-Maghaziع" and "Al-Dar-Rafi Akhtisar al-Maghaziwa-Al-Seer الدروفي اختصار المغازي والسير by Ibn Abdul Bar. Later, jurists began to use the word "Al-Sir al-Sir al-Saghir السير المعاري and "Al-Sir al-Kabir" works on foreign relations were titled "Al-Sir al-Saghir السير الصغير المعاري" and "Al-Sir al-Kabir". In the past, "Seerah" was used to refer to the circumstances of the Prophet's life; today, "Seerah" is also used to refer to the events of the Prophet's life, peace and blessings be upon him.<sup>8</sup> It covers every element of his life, including the social, political, military, and personal spheres.

#### Women's contributions to the field of seerah:

Writing down the Prophet's (peace and blessings of Allah be upon him) life circumstances began during his Companions. To preserve the Prophet Muhammad <sup>28</sup> life, his friends used to record his specifics. Zubair Urwa's son<sup>9</sup>. Muhammad Ibn Ishaq wrote the first biography book, according to Haji Khalifa's account in "Kushf al-Zunun."<sup>10</sup> However, it is essential to remember that biographical writing began during the Prophet's House and began with Hazrat Khadijah Al-Kubari, the Prophet Muhammad <sup>28</sup> wife. When he returned home and told Hazrat Khadijah (RA) about the first divine revelation, she commented onhis(Muhammad <sup>28</sup>) life:

كَلًا وَاللَّهِ مَا يُخْزِيكَ اللَّهُ أَبَدًا، إِنَّكَ لَتَصِلُ الرَّحِمَ، وَتَحْمِلُ الكَلَّ، وَتَكْسِبُ المَعْدُومَ، وَتَقْرِي الضَّيْفَ، وَتُعِينُ عَلَى نَوَائِبِ الحَقِّ<sup>11</sup>

May Allah never dishonor you. You are devoted, you pay the right to feast visitors, and you are always persistent and helpful in areas of truth.

These words marked the start of biographical writing, and women were honoured to do so. The circumstances surrounding the Prophet are then described in the traditions transmitted by Hazrat Aisha Siddiqa; may Allah be pleased with her. Without a doubt, it can be added to the biography. According to Dr. Mahmood Al HasanArif:

His work is the most significant in biography because, unlike other Companions, most of the traditions he transmitted were based on firsthand hearing and observation rather than hearsay.<sup>12</sup>

Apart from Sayyida Aisha (may Allah be pleased with her), those Companions who participated in various campaigns and told the events relating to these campaigns, when the period of compilation and editing of Seer and Mughazi arrived, their research and traditions were based on mutual discussion. Work has been completed. This was the biographer's erratic start. Male biographers like IbnIshaq and others authored notable books on the biography of the Prophet based on these Arabic literary traditions. Still,women published no authorial works in this field.This was the scenario with the Urdu language till the 18th and 19th centuries. Later, other volumes by female biographers were written, and this process is currently ongoing. A conservative estimate places the number of books authored by women published in Urdu at over 150, some of which are genuinely regarded as significant contributions to their fields.<sup>13</sup>

#### Brief Analysis of Women's Biographical Trends:

Without a doubt, there have been a lot of excellent and insightful books in the biography genre written by both men and women. Enumerating the books published between the end of the twentieth century and the present is tricky. The biography of the Prophet (peace be upon him) has enormous possibilities due to its vast reach; female biographers have made good use of it in their way, and on this basis, it can be argued without exaggeration that biography education for

children should or should not be done. For individuals interested in science and knowledge, we locate the trending work of female biographers in every area of biography in different aspects of the Prophet's life, research style, or literary writing style. In this context, we locate the most essential work on the research and analytical trend related to contemporary topics.

In the 20th century, Urdu biography underwent a significant movement that gave it a prominent place in biographical literature: the emphasis on the practical application of Sirat Tayyaba. This trend naturally evolved to show the extent of Islam's religion and the significance and purpose of the Prophet's life in the modern era<sup>14</sup>. Instead, new facets of biography are developing throughout history. According to Dr Mahmood Ahmad Ghazi (2010-1950):

With the revelation of new aspects of Sirat Mubaraka, it feels as if the work on Sirat Sarwar Anbiya has just begun. Now, a new world of research, a new set of research, and a new research universe have been discovered.<sup>15</sup>

Without a doubt, it is a distinction of the Prophet's life because, even after more than fourteen centuries, his life and teachings help solve all of society's issues in all spheres of life. Female biographers have also demonstrated their research skills in this dimension, and women experts in various areas have brought out many bright parts of the Prophet's biography by uncovering hints in their fields of expertise. It is no accident that female biographers also know how critical it is to examine fresh perspectives on biography. About the establishment of peace, biographer Zeenat Haroon writes as follows:

At this time, there is a need to consider every aspect of the life of the Holy Prophet <sup>##</sup> that will guide us practically in the establishment of peace, so I have discussed it concerning the teachings of the Holy Prophet (peace and blessings of Allah be upon him). Along with other reforms for humanity in Madani's life, he gave the establishment of peace his complete focus.<sup>16</sup>

Even in recent years, the number of female biographers has expanded yearly, and many significant papers and books have been published. It would be more accurate to call this era the "golden age" of female biographical writing. Several notable study books have emerged, particularly since the beginning of the twenty-first century. However, we will further explore some of the books the Government of Pakistan granted in the biography field.

This book is 239 pages long, with eight chapters, footnotes, concluding remarks, and sources. Each chapter concludes with a separate list of references. The author tried to meet the time constraints in these articles by including the first and second sources, earlier research, geographical, scientific, medical, technical, analytical, and experimental materials, in addition to the most recent research and practical seminars and reports.<sup>18</sup>

Has declared the fact that psychologists have been drawn to the biography and teachings of the Prophet, peace and blessings be upon him, in which there is a cure for every difficulty and disease, the need is only for the truth, is further evidence of the book's universality concerning its subject.<sup>20</sup>

- Salh Hudaybiya Took part on Monday.
- Makkah was conquered on Monday.

In the book's introduction, the author mentions Monday as follows:

Because Allah Ta'aala gave Monday significant weight in several contexts and because it played an essential role in the life of the Holy Prophet, we must value this day highly.

By reading this book, one can learn about Arbab devotion and the significance of Monday (two Saturdays). The book's approach is straightforward, and the language is smooth. As the points have been explained, the vocabulary and expression have also grown in some locations, which is the manners of biography. In opposition, the book is cited, and a bibliography is provided at the conclusion, but once more, there is an excessive dependence on secondary sources.<sup>22</sup>
